FBCAS Monthly Shelter Statistics Report – March 2019

From March 1, 2019 through March 31, 2019, the overall save rate for FBCAS was 96%. The save rate for dogs was 97% and for cats it was 95%. *

March marks the 8th consecutive month that FBCAS has had a save rate of 90% or greater for our pets in the shelter.

- 82 feral/community cats were returned to field as part of our Community Cat Program for March 2019.
- The save rate does not include 3 dogs that were owner requested euthanasia (ORE) for the month of February 2019.
 - One ORE was for a head to lab bite investigation, 2 owners requested euthanasia due to age and health (both dogs had cancer).
- Five additional dogs were humanely euthanized at FBCAS.
 - Three dogs were humanely euthanized for extreme behavior issues, one was severely injured on intake and one was a head to lab bite investigation.
- Two dogs died in care.
 - One puppy died in foster care hours after birth. One puppy died in the shelter hours after birth.
- Four cats were humanely euthanized at FBCAS. All four cats were severely injured when picked up in the field.
- Two cats died in care.
 - One cat was severely injured on intake. The other cat died post spay surgery.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.

Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.

*Formula used: Intake minus all euthanasia outcomes divided by intake minus owner requested euthanasia
