FBCAS Monthly Shelter Statistics Report – May 2019

From May 1, 2019 through May 31, 2019, the overall save rate for FBCAS was 92%. The save rate for dogs was 97% and for cats it was 88%. \* It was a very busy month for us with 428 dogs and cats coming into the shelter.

May marks the 10<sup>th</sup> consecutive month that FBCAS has had a save rate of 90% or greater for our pets in the shelter.

• 76 feral/community cats were returned to field as part of our Community Cat Program for May 2019.

## Dogs:

- The save rate does not include 2 dogs that were owner requested euthanasia (ORE) for the month of May 2019.
  - o One dog was a head to lab bite investigation for biting a child and the other was an elderly, blind dog.
- Three additional dogs were humanely euthanized at FBCAS.
  - Two dogs were humanely euthanized for extreme behavior issues, one was severely injured on intake after being hit by a car.
- Three dogs died in care.
  - One dog died en route to the shelter after sustaining injuries after being hit by a car.
     One was a head to lab bite investigation and the other dog died shortly after testing positive for Parvo.
- One dog was lost in care.

## Cats

This was a very challenging month for all of us at FBCAS with 163 kittens under 5 months coming in over the 31 days and losing some of our neonate and kitten population that failed to thrive or could not withstand upper respiratory infections, despite our best efforts.

- The save rate does not include 2 cats that was an owner requested euthanasia (ORE) for the month of May 2019
  - Both cats were head to lab bite investigations.
- Six cats were humanely euthanized at FBCAS.
  - o Three cats were euthanized for aggressive behavior. These cats were owned cats, one bit two employees.
  - Three cats were severely injured on intake, two were hit by a car.
- Twenty four kittens died in care or were humanely euthanized for medical reasons. Two of those kittens were bottle babies in foster care.

Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.

<sup>\*</sup>Formula used: Intake minus all euthanasia outcomes divided by intake minus owner requested euthanasia
