FBCAS Monthly Shelter Statistics Report – July 2021

From July 1, 2021 through July 31, 2021, the overall save rate for FBCAS was 93%. The save rate for dogs was 93% and for cats it was 92%.*

- 164 feral/community cats were returned to field as part of our Community Cat Program.
- 28 dogs and 2 cats were returned to their owners through our Return to Owner/Return in Field programs.

Dogs:

- One dog died from unknown causes in the shelter.
- One dog died from complications during emergency surgery for a suspected blockage.
- Two newborn orphan puppies died in foster care.
- One over the counter stray puppy was humanely euthanized for severe illness on intake.
- Three dogs were humanely euthanized for head-to-lab bite investigations.
- One dog was humanely euthanized at the request of their owner for severe aggression.
- One dog was humanely euthanized for severe aggression towards staff and visitors.
- Three dogs were humanely euthanized at the request of their owner for severe aggression towards family members.

Cats:

- Five neonatal kittens died due to failure to thrive in foster care.
- Nine neonatal kittens died due to failure to thrive in the shelter.
- One cat was humanely euthanized after coming into the shelter with severe injuries from suspected hit by car.
- Two neonatal kittens were humanely euthanized after coming into the shelter with severe illness.
- One community cat were humanely euthanized after their coming into the shelter with severe illness.
- One neonatal foster kitten was humanely euthanized after coming back with a severe illness.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.

Since August 2018 FBCAS has maintained a 90% or more save rate for the pets that come into our shelter. Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.
