FBCAS Monthly Shelter Statistics Report – August 2021

From August 1, 2021 through August 31, 2021, the overall save rate for FBCAS was 95.6%. The save rate for dogs was 96% and for cats it was 95%.* This month marks 36 consecutive months of maintaining a 90% or more save rate for the pets in our shelter.

- 112 feral/community cats were returned to field as part of our Community Cat Program.
- · 31 dogs were returned to their owners through our Return to Owner/Return in Field programs.

Dogs:

- Two dogs were humanely euthanized at the request of their owners for head-to-lab bite investigations.
- · Two dogs were humanely euthanized for severe aggression towards staff and visitors.
- Two senior dogs were humanely euthanized at the shelter that were returns from end of life foster care.

Cats:

- · Two neonatal kittens died due to failure to thrive in foster care.
- · Three neonatal kittens died due to failure to thrive in the shelter.
- · One cat died after coming into the shelter with severe injuries from suspected hit by car.
- · Four neonatal kittens were humanely euthanized at the shelter due to severe illness.

Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.
