FBCAS Monthly Shelter Statistics Report – January 2021

From January 1, 2021 through January 31, 2020, the overall save rate for FBCAS was 96%. The save rate for dogs was 96% and for cats it was 96%.*

- 163 feral/community cats were returned to field as part of our Community Cat Program.
- 18 dogs and 4 cats were returned to their owners through our Return to Owner/Return in Field programs.
- 258 spay/neuter surgeries were performed by our veterinary team.

Dogs:

- · One neonatal puppy died after being surrendered to us very ill.
- One dangerous dog was humanely euthanized at the request of its owner.
- One foster dog was humanely euthanized after suffering traumatic injuries.
- One severely ill dog was humanely euthanized.
- Two dogs were humanely euthanized as part of head to lab bite investigations.

Cats:

- · One senior cat died after being surrendered to us very ill.
- One cat died after suffering traumatic injuries in the field.
- Three severely ill cats were humanely euthanized.
- Four cats were humanely euthanized suffering severe trauma from being hit by cars.
- · One cat was humanely euthanized as part of a head to lab bite investigation.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.

Since August 2018 FBCAS has maintained a 90% or more save rate for the pets that come into our shelter. Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.
