FBCAS Monthly Shelter Statistics Report – March 2022

From March 1, 2022 through March 31, 2022, the overall save rate for FBCAS was 96%. The save rate for dogs was 96% and for cats it was 96%.*

- 58 feral/community cats were returned to field as part of our Community Cat Program.
- 21 dogs and 2 cats were returned to their owners through our Return to Owner/Return in Field programs.

Dogs:

- One dog was humanely euthanized for aggressive behavior towards staff and public.
- One dog was humanely euthanized for after bite incidents with staff and public.
- One senior dog was humanely euthanized after their condition deteriorated.
- One dog was humanely euthanized for a head to lab bite investigation.
- One dog died as a result of hit by car injuries.
- One dog died as a result of illness.

Cats:

- One cat was humanely euthanized due to severe hit by car injuries.
- One community cat was humanely euthanized due to severe illness.
- One cat died en route due to severe injuries suffered the field.
- One was humanely euthanized when failing to thrive.
- One hours old kitten was humanely euthanized due to severe illness.

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
