FBCAS Monthly Shelter Statistics Report – August 2023

This month marks 5 years that FBCAS has saved 90% or more of the pets that have come into our shelter. We are so very proud of our lifesaving efforts and thank everyone who has helped us achieve this amazing milestone. From August 1, 2023 through August 31, 2023, the overall save rate was 97%. The save rate for dogs it was 96% and for cats it was 98%

As we move forward though, we need your help more than ever to continue to keep our save rate at 90% or more. We are in a crisis situation unlike any we have seen here before and we need your help to adopt and foster. We cannot continue to operate our shelter at over 200% capacity and have dogs living in crates in the hallways and in offices. We have more than a dozen dogs who have been with us for more than a year, some now closing in on two years and while we know we have great dogs, we also have to consider their quality of life here and need to find them homes. Please help us to help them.

- 130 feral/community cats were returned to field as part of our Community Cat Program
- 7 dogs were returned to their owners through our Return to Owner/Return in Field programs

Dogs:

- One puppy died after a severe illness.
- One dog was humanely euthanized after suffering from severe illness on intake
- Two dogs were humanely euthanized for bites and or aggressive behavior towards the public and staff
- Two dogs were humanely euthanized at the request of their owners for bite investigations

Cats:

- Two neonatal kittens died, failure to thrive
- One cat was humanely euthanized after suffering severe injuries in the field
- One cat was humanely euthanized due to severe illness suffered in the field

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population. Our dedicated staff would like to thank all of our adopters, rescue partners, fosters, volunteers and community members who played a part in every life saved at FBCAS this month.
