FBCAS Monthly Shelter Statistics Report – December 2024

From December 1, 2024 through December 31, 2024, the overall save rate for FBCAS was 92%. The save rate for dogs was 93% and for cats it was 91%.*

Since August 2018, FBCAS has maintained a 90% save rate for the pets entering our shelter.

- 62 feral/community cats were returned to field as part of our Community Cat Program
- 10 dogs and 1 kitten were returned to their owners through our Return to Owner/Return in Field programs

Dogs:

- One neonatal puppy died in shelter - failure to thrive
- One dog was humanely euthanized due to severe injury
- Two dogs were humanely euthanized due to aggression towards staff and public
- One dog was humanely euthanized at the request of their owner as part of a bite investigation

Cats:

- One neonatal kitten died in foster – failure to thrive
- One neonatal kitten died in shelter– failure to thrive
- Four kittens were humanely euthanized due to severe illness or injury
- One cat was humanely euthanized due to severe illness
- One senior cat died in care

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
