FBCAS Monthly Shelter Statistics Report – November 2024

From November 1, 2024 through November 30, 2024, the overall save rate for FBCAS was 90%. The save rate for dogs was 90% and for cats it was 90%.*

Since August 2018, FBCAS has maintained a 90% save rate for the pets entering our shelter.

- 73 feral/community cats were returned to field as part of our Community Cat Program
- 9 dogs and 1 cat were returned to their owners through our Return to Owner/Return in Field programs

Dogs:

- Two neonatal puppies died in shelter - failure to thrive
- One neonatal puppy was humanely euthanized - failure to thrive
- One dog died en route to the shelter due to severe injuries
- One dog was humanely euthanized due to severe illness.
- Two dogs were humanely euthanized due to aggression towards staff and public
- Two dogs were humanely euthanized at the request of their owners as part of head-to-lab bite investigations.

Cats:

- Five neonatal kittens died in shelter – failure to thrive
- One kitten was humanely euthanized due to severe illness or injury
- One cat died while in fospice
- Four cats were humanely euthanized due to severe illness or injury

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
