FBCAS Monthly Shelter Statistics Report – October 2024

From October 1, 2024 through October 31, 2024, the overall save rate for FBCAS was 94%. The save rate for dogs was 91% and for cats it was 95%. *

Since August 2018, FBCAS has maintained a 90% save rate for the pets entering our shelter.

- 117 feral/community cats were returned to field as part of our Community Cat Program
- 6 dogs and 2 cats were returned to their owners through our Return to Owner/Return in Field programs

Dogs:

- One puppy died in shelter due to severe illness
- 5 neonatal puppies died in shelter – failure to thrive
- Two puppies were humanely euthanized due to severe illness
- One dog was humanely euthanized due to severe injury
- One dog was humanely euthanized due to aggression towards staff and public

Cats:

- Two kittens died in shelter – failure to thrive
- One cat died in shelter due to severe illness
- Three kittens were humanely euthanized due to severe illness or injury
- Four cats were humanely euthanized due to severe illness or injury

* Beginning and ending shelter totals have an acceptable variance of .5% due to database variances in intake and outcome dispositions of the shelter population.
